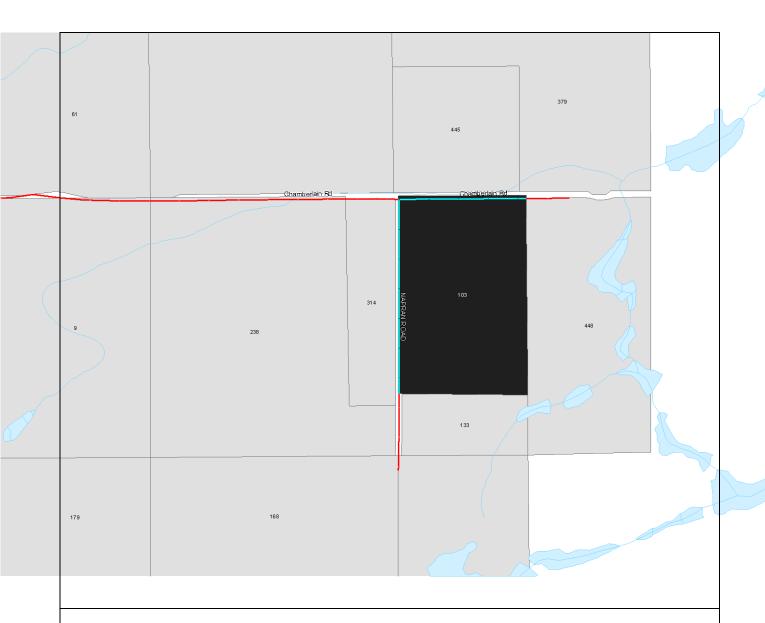
**Public Input:** No public input was received which effected the decision of the Board.
