IF A PERSON OR PUBLIC BODY THAT FILES AN APPEAL of a decision of the Sudbury East Planning Board in respect of the proposed consent does not make written submissions to the Sudbury East Planning Board before it gives or refuses to give a provisional consent, the Local Planning Appeal Tribunal may dismiss the appeal.

IF A PERSON OR PUBLIC BODY does not make oral submissions at a public meeting or make written submissions to the Sudbury East Planning Board before the by-law is passed, the person or public body is not entitled to appeal the decision of the Sudbury East Planning Board to the Local Planning Appeal Tribunal and that person or public body may not be added as a party to the hearing of an appeal before Local Planning Appeal Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Any person or public body may attend the Public Hearing and/or make written or verbal representations either in support of or in opposition of the Proposed applications.

Purpose and Effect of the Proposed Consent and Zoning By-law Amendment

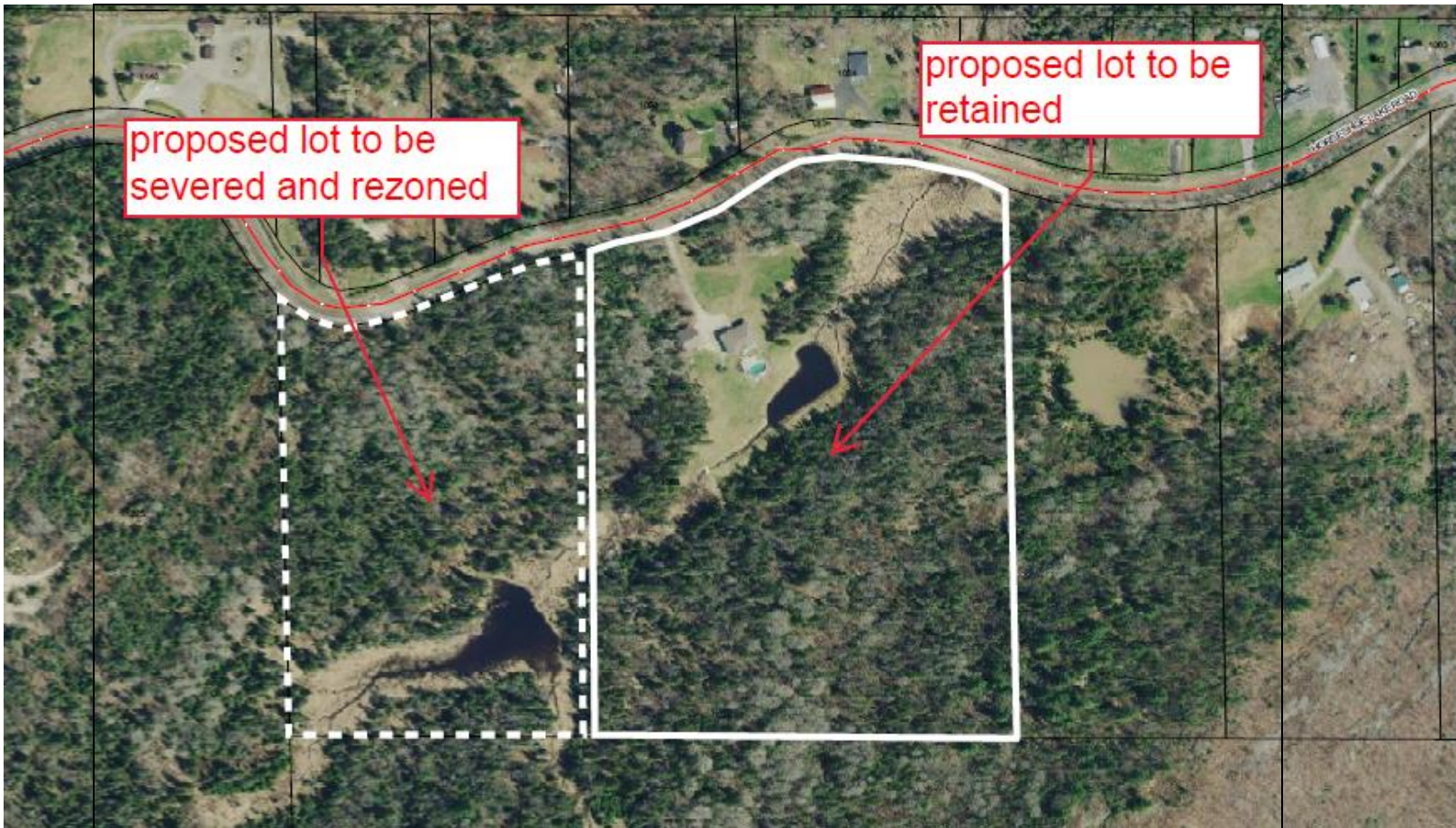

The purpose of the Public Hearing will be to consider a proposed amendment to Zoning By-law 14-01 of the Unincorporated Townships of the Sudbury East Planning Area, pursuant to the provisions of Section 34 of the Planning Act, R.S.O. 1990, Chapter P.13 and a consent under section 53(5) of the Planning Act, R.S.O. 1990.

An application has been received from Bryan and Marnie Teddy, to rezone lands described as Part of Lot 6, Concession 6, in the Unincorporated Township of Secord, Territorial District of Sudbury (Parcel 25720 Sudbury East Section).

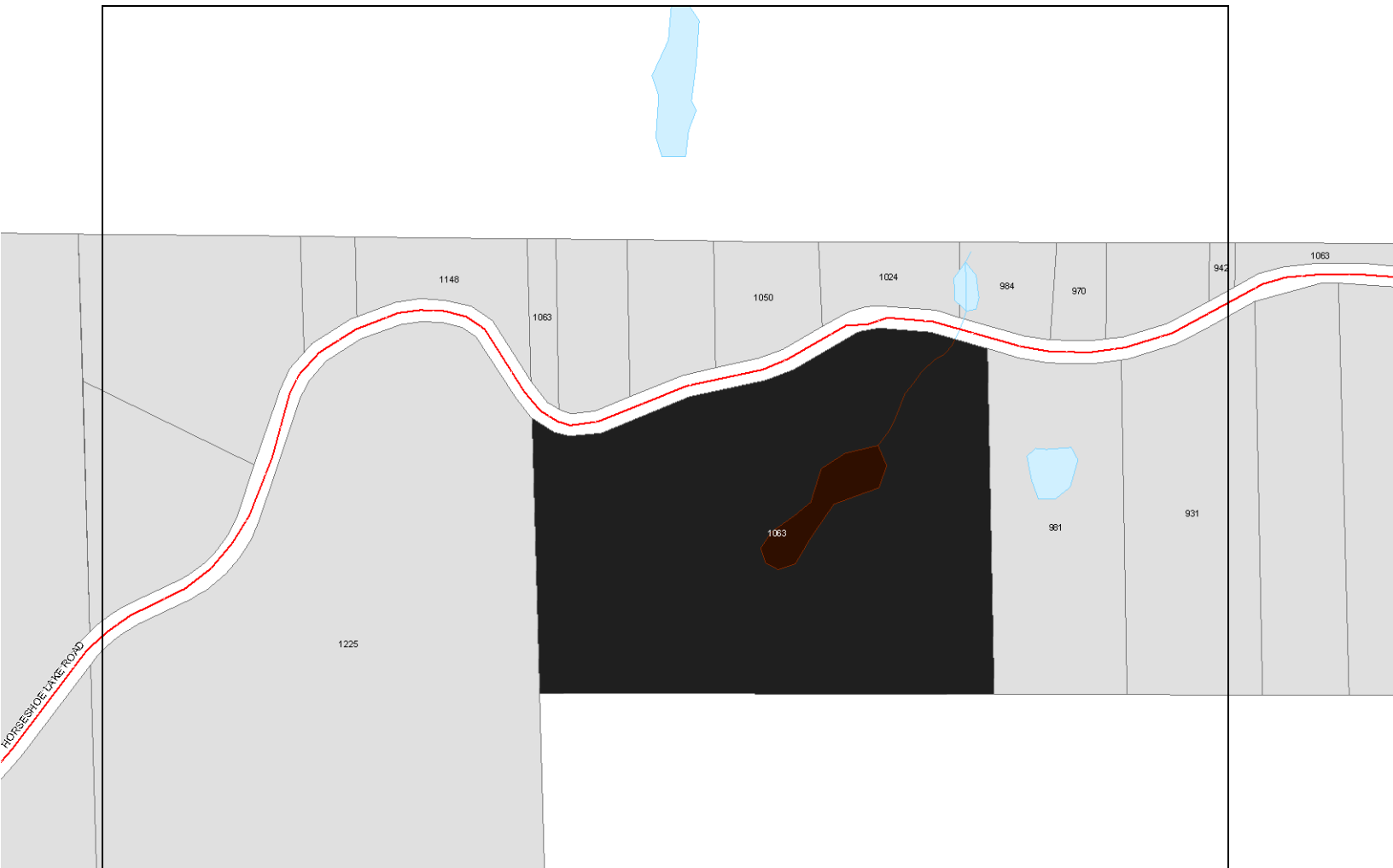
The subject lands are presently zoned Rural (RU) under Zoning By-law 14-01 of the Unincorporated Townships of the Sudbury East Planning Area. The Proposed Zoning By-law Amendment will rezone the lot to be severed through consent application B/18/20/SCR to Residential Rural (RR) in order to recognize the intended use of the lot.

The subject property is located within the **Rural Policy Area** designation of the Official Plan for the Sudbury East Planning Area (adopted April 27th, 2010, approved by the Ministry of Municipal Affairs and Housing September 28th, 2010).
